This MEMORANDUM OF UNDERSTANDING IS ENTERED INTO ON 10th October 2013 to 09th October 2023 between, the **Rajgad Institute of Management, Research & Development,** Opp. Dhankawadi Post Office, Satara- Pune Road, Dhankawadi, Pune, Maharashtra 411043 hereafter referred to as **RIMRD** and **Shri Chhatrapati Shivaji College of Engineering, Dhangawadi, Gat No. 237, Pune Banglore Highway, Dhangawadi Tal. Bhor, Dist- Pune. Pin code -412206** hereafter referred to as **SCSCOE**.

PREAMBLE

Collaborative efforts in engineering education have become the key to success. The TEQIP project encourages institutions to establish MoUs with neighboring institutions and Industries on viable collaborative / consultancy project with specific time-frames and well-defined outputs. The collaboration could be in the areas of joint projects of students and faculty, joint publications, joint sponsored projects from funding agencies, joint faculty and staff development programmes, joint consultancy projects with a sound revenue sharing model etc. The institutions are required to establish collaboration through MoUs. The two institutions signing this MoU have agreed to work on the philosophy mentioned in this preamble.

2. PURPOSE

The aim of this MoU is primarily to establish a written document under which both the institute (RIMRD) & institute (SCSCOE) may enter into a written agreement to perform collaborative programmes in the areas of mutual interest.

3. AREA OF COLLABORATION

Areas in which RIMRD and SCSCOE may collaborate are as follows:

- I. Start Collaborative Research Programme of mutual interests.
- II. Developing Centre of Excellence.
- III. Faculty exchange program (Expert Lectures, STTPs, Workshops etc.) between RIMRD and SCSCOE.
- IV. Provide training on latest technology available in the institution.

Any other activity not covered by this MoU shall be decided on a case to case basis by the two institutions – RIMRD and SCSCOE.

4. AGREEMENT OF COLLABORATIVE PROGRAMMES

Each such collaboration undertaken by the institutes shall describe in details the following:

- The nature, scope and the time of collaborative schedule.
- Any other provision as deemed to be necessary and agreed by both.

To prepare and finalize a concrete action plan and schedule for collaboration on priority areas as agreed upon by both.

5. NODAL AUTHORITY

The Nodal Officer from RIMRD Pune shall be the Principal, RIMRD, Pune or his nominee and the Nodal Officer from SCSCOE shall be the Principal, SCSCOE, Pune or his nominee for all decision making and concurrence.

6. IMPLEMENTATION AND ACTION PLAN

RIMRD and SCSCOE Pune shall endeavor to finalize the details of implementation and action plan of collaborative efforts to execute the parts of this MoU from the academic year 2017-21.

This MoU shall be effective from the date of signing the same and shall remain in effect for the subsequent four years and may be renewed or discontinued thereafter by mutual consent.

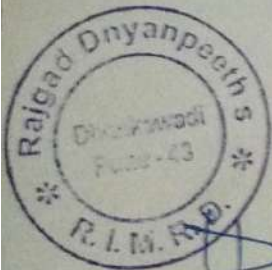
